Background:

Empowering cultural enrichment in Tyne & Wear

Established in 2010, Tyne & Wear Archives & Museums Development Trust (TWAM Development Trust) serves as the charitable arm of Tyne & Wear Archives & Museums (TWAM), striving to support and enrich a diverse array of museum activities. Situated across Tyneside, TWAM manages a collection of nine museums and galleries, each housing collections of international significance spanning various domains such as archives, art, science, technology, archaeology, military and social history, fashion, and natural sciences. Supported by local authorities, Newcastle University, and Arts Council England, TWAM operates as a National Portfolio Organisation, committed to enriching community life through cultural engagement.
